## NEW ORLEANS SAINTSATIONS

The New Orleans Saints are proud to announce auditions for the 2016-17 New Orleans Saints Cheerleading Team, the Saintsations, will be held on Sunday, April 17th.

The Saintsations are comprised of two separate teams. According to team director Lesslee Fitzmorris, "Each team plays a vital role in our mission to provide the "best" cheerleading team that represents not only the Saints and but our community throughout the world. The popularity of the Saintsations, both locally and internationally, has made it necessary to expand the team to accommodate our growing fan base." Applicants may audition for one or both teams.

### **Appearance Performing Team:**

The focus of the Saintsation Appearance Team will be community outreach, game day appearances, stadium performances and media relations.

Applicants should be able to possess public speaking skills and dance technique. Benefits of membership on this team include extensive community relations and marketing experience, media training and a shorter rehearsal schedule.

### **Field Performing Team:**

The focus will be community appearances and on field performances.

Applicants should be able to possess extensive dance technique. Benefits of membership on this team include extensive dance training, community relations and a regimented rehearsal schedule.

Both teams will make community appearances on behalf of the New Orleans Saints. Both teams will be featured in the Saintsations "Making of the Calendar" Televised Show, featured in the team swimsuit calendar, team poster and internet.

### REQUIREMENTS:

- Candidates must be at 18 years of age on or by the date of preliminary auditions.
- Proof of age is required (please bring certified copy of birth certificate OR a Driver's license).
- Membership on the Saintsations team is for one (1) year. No preference is given to returning members. All returning Saintsations must re-audition annually.
- Please complete the Application Form, the Medical Release Form, and the Consent Form and bring with you to auditions or at the audition workshop.
- Those selected for the squad will be required to attend two weekend clinics
- on Sunday, June 26th and July 24th.
- Rehearsals will be held on Tuesday and Thursday during the first three weeks of May. Rehearsals beginning in the last week of July and August will be on Tuesday and Thursdays. During the fall, there will rehearsals Thursday before a home game and Four Sunday workshops. Additional rehearsals may be required during the fall. The appearance team has less rehearsals during the year.
- There will be a first meeting and rehearsal on Sunday, April 24<sup>th</sup> and Tuesday, April 26<sup>th</sup>

- The calendar shoot and retreat is optional and scheduled between May 30th-June 3<sup>rd</sup>.
- N.F.L. cheerleaders do not attend away games, but are expected to perform at all home games at the Louisiana Superdome as well as any additional home pre-season or playoff games. Should the Saints play in the Super Bowl, the squad may make the trip. Travel out of New Orleans and appearances for corporate and charitable organizations are cast based on individual availability. All members of the Saintsations Team will need to provide their own transportation to all rehearsals and performances.

## **AUDITION PROCESS DESCRIPTION:**

*ALL STEPS OF THE AUDITION PROCESS ARE CLOSED*

There are five steps to the audition process for membership on the New Orleans Saintsations Team.

### **STEP 1-Registration**

Applicants must first complete the audition registration packet which consists of the following forms: Registration, waiver and consent forms. You may register online or download the packet at [www.neworleanssaints.com](http://www.neworleanssaints.com) or [www.saintsations.net](http://www.saintsations.net). If you download the packet, please email the completed version to [saintsations2@gmail.com](mailto:saintsations2@gmail.com) or mail it to PO BOX 1062 Mandeville, LA 70470. We suggest pre-registering.

Be sure to check off if you are auditioning for the Appearance Team, Field Team or both. If you audition for both, then the judges will determine which team you will be best suited for membership.

### **STEP 2-Audition Workshops**

**Sunday, March 13th (2:00-4:00pm) AND/OR Thursday, March 31 (7:30-9:30) AND/OR  
April 14th(7:30-9:30)**

There are two audition workshops scheduled. The same material will be taught at both locations. You may choose the date or location that is most convenient, you may go to both, or you may elect to skip the workshop entirely. The purpose of the optional workshop is to better prepare each participant for the audition process. Please note that attendance at this workshop is included in your registration process. Attendance at this workshop is **optional** and is not required. Participation in this workshop will have no effect on your selection to the team. However, a great deal of information will be shared as well as an improved understanding of what it takes to make the squad and what to look forward to if you do. You must be 18 years of age by the date of the workshop to attend. Please wear comfortable dance clothes with sneakers/dance shoes because you will also be learning a routine similar to that of the tryout routine.

### **STEP 3-Preliminaries**

There are three parts to preliminaries.

**First**, applicants will be required to complete the registration process, which includes registration paperwork, photograph, introduction, and personal information (height, weight, and measurements). There is a \$75.00 audition fee. This includes participation in one or both workshops. You may register online or in person at either workshop or on the first day of auditions, Sunday, April 17th.

**Second**, applicants will be evaluated on dance technique including kicks, leaps, and turns. There will be 30 seconds of free dance as well. A brief dance routine will be taught and performed in small groups before the judges. Applicants should come prepared to introduce themselves to the judges. Judges may require additional dance requirements.

Eliminations will be made throughout the day. At the end of the day, those advancing to the semi-finals will be posted. Semi-finalists will need to submit a brief home video giving us a background on you and why you want to join the team!

***PRELIMINARY ATTIRE: Performers must wear a black solid two- piece ensemble (trunks or shorts only, no skirts or pants), flesh colored tights and dance shoes (jazz, character, ballet, etc.) Carmel's Dance Wear in Metairie is the official dance wear store of the Saintsations and is familiar with proper audition attire.***

Only participants and audition staff will be allowed in the facility during the preliminary audition process.

### **STEP 4-Semi-Final Auditions**

**Semi-Final Auditions: Tuesday, April 19th, 6:30pm  
Franco's Athletic Club, Mandeville, Louisiana**

The semi-final auditions will be the interview portion of the audition process. Professional interviews will be conducted with each participant in 15 minutes intervals. Business leaders from throughout the greater New Orleans region will conduct the interviews. Following the interviews, a test covering the NFL will be administered to each participant. Eliminations will be made after the semi-finals.

Participants will perform the audition routine in smaller groups before the judges. A black two-piece ensemble (trunks or hot shorts only, no skirts or pants), flesh colored tights and dance shoes should be worn. An audition top will be provided. Technical skills will be evaluated along with overall dance performance and speaking skills

# 2016 NEW ORLEANS SAINTSATIONS AUDITION WORKSHOP

## **Thank you for your interest in auditioning for the 2016 New Orleans Saintsations Squad!**

The New Orleans Saintsations will host optional audition workshops in two locations. The same material will be taught at both workshops. You may attend either (or both) workshop(s). Your registration fee of \$75.00 covers the cost of participation in the clinics

The purpose of this workshop is to help participants become better prepared for the audition process. Please note that attendance at this clinic is included in your registration fee. Attendance is not required to audition and does not guarantee a position on the squad. However, a great deal of information will be shared as well as an in-depth understanding of what it takes to make the squad and what to look forward to as a member of the Saintsations!

This workshop is open to registered participants only. Guests will not be permitted inside the event facility. Upon your arrival, you will be required to sign a waiver prior to your participation in the workshop. After a brief registration process, a group warm-up will be conducted. Next, you will be taught dance combinations, which will be taught at a slightly slower pace than at try-outs. These combinations will be different from the routines you will learn at preliminary auditions; however they will familiarize you with the style and level of dance ability that is expected of squad members.

The next segment of the program will be a detailed discussion regarding the agenda for the audition days, judging criteria, proper attire, (what colors and cuts look best for the dance audition, resume and photo requirements, and most importantly, some tips on how to have an outstanding interview.

You will also be informed on what to expect should you be selected for the 2015 squad including information on rehearsals, personal appearances, photo shoots, game days, etc. The discussion will end with a question and answer segment. For the workshop, you should wear dance attire and sneakers/dance shoes. Be sure to bring plenty to drink and a snack. Additionally, it is also important to bring a notebook and pen to take notes during the discussion segment. The most important material you'll take home with you will be practical and valuable information on the audition process.





## Frequently asked questions

### ***Is there an age limit?***

You must be 18 by the audition date. You must present a valid Driver's License.

### ***How do I register?***

You register by visiting our website at [www.neworleanssaints.com](http://www.neworleanssaints.com) or [www.Saintsations.net](http://www.Saintsations.net) and filling out the online registration form. You will also need a letter of recommendation, headshot, and one page describing why you want to be part of the New Orleans Saintsations. You may register and pay the registration fee on-line or you may bring the forms and cash with you to either audition workshop or on audition day, Sunday, April 17<sup>th</sup>. NO CHECKS accepted.

### ***What do the judges look for at auditions?***

We are looking for dedicated young women who are physically fit, talented in dance / cheer, lead a healthy, productive lifestyle, and are able to present themselves in a professional manner. You will be judged on professional presentation, dance ability, fitness, and interview skills.

### ***Does my headshot need to be professionally taken?***

The headshot is simply used to identify you at auditions. It will not be returned, so a recent snapshot will be fine. It is not necessary to have a professional photo taken.

### ***How should I fix my hair and makeup?***

Judges will see you close up at auditions. Hair and make-up should be "performance" ready. You should wear more makeup than on a normal day, but not too heavy. Hair can be worn in any style, as long as it doesn't interfere with your performances.

### ***Are there any height or weight requirements?***

We do not have specific height or weight requirements. However, you must be physically fit. Being a Saintsation requires a high level of athleticism.

### ***What can I do to prepare for auditions?***

Beginning now, you should brush up on dance and technique skills. Being physically fit is part of being a Saintsation; you should maintain a healthy lifestyle. We suggest working out with a trainer and enroll in a dance studio to understand terminology and required skills. The Audition Workshops are a great way to fully understand the audition process. You will learn requirements for being a member, opportunities that come along with the team, as well as part of the audition routine. Technical skills that may be incorporated into other choreography will also be reviewed.

***What should I bring to auditions?***

You should bring your completed application, headshot, resume', and essay, along with the registration fee. Your attire should flatter your figure and meet our guidelines. If you previously submitted information, you can substitute items at this time. You must wear a two-piece black outfit (brief or hot short bottoms). You may bring snacks and drinks since you will be at Preliminary auditions for a majority of the day. Tan jazz shoes should be worn. (You will NOT allowed to perform barefoot) Personal items such as curling irons and make-up are also suggested.

***Are auditions open to the public?***

No. Every segment of auditions is closed to outside guests.

***When and where do the Saintsations rehearse?***

Practices begin immediately after tryouts conclude. The team practices from 7-9 pm on Tuesdays and Thursdays during the months of May, August-December the team rehearses the Thursday night before a home game and at 4 Sunday clinics. Additional rehearsals on Tuesday or Thursday may be called. Field rehearsals on game days begin as early as 8 am. Rehearsals rotate at locations in Mandeville, Baton Rouge, Metairie and New Orleans. The Appearance Team will have a more limited rehearsal schedule.

***Does the team travel to away football games?***

Saintsations do not travel with the Saints to regular season or playoff away games. There are other travel opportunities during the year that may be mandatory.

***Do I need to bring a prepared routine to auditions?***

No, you do NOT need to prepare a routine for auditions. You will be taught the routines as part of the audition process.
